On Monday, May 8, 2023, the City Council will have a Dinner Meeting with the Shoreline Planning Commission to discuss the Commission's accomplishments from the prior year and to discuss the Commission's upcoming workplan. This is an opportunity for the Council and Commission to discuss topics for the upcoming year and issues of importance to both bodies.

Shoreline Municipal Code section 2.20.060 Duties-Responsibilities (F) states:

"The planning commission shall submit written periodic reports annually to the city council setting forth its progress in completing its work program for the current fiscal year."

Traditionally, the Planning Commission has submitted a letter to the City Council in advance of the annual joint City Council and Planning Commission dinner meeting. Because of COVID-19 restrictions, the Planning Commission has not met with the Council since February 2020. **Attachment A** to this memo provides a letter prepared by the Planning Commission that serves as the annual report to the City Council.

The purpose of this meeting is to engage in a dialogue that serves as an update to the City Council by including a summary of the Planning Commission's activities for the past year and to meet the Commissioners, especially the two new members of the Planning Commissioners appointed in March 2022 – Leslie Brinson and Christopher Mosier.

#### 2021 and 2022 Accomplishments and 2023 Work Plan

Since the last annual report to the City Council on February 8, 2020, the Planning Commission has advised the Council on several projects of note. The Planning Commission spent 2021 and 2022 studying and providing recommendations to the Council on:

- 2021 and 2022 Comprehensive Plan Amendments including a complete update to the Transportation Element and review of key components of the revised Transportation Master Plan;
- Housing Action Plan;
- Permanent regulations for Outdoor Seating;
- Permanent regulations related to Enhanced Shelters;
- Cottage Housing Development Code Amendments (almost complete);
- Transfer of Development Rights Program and TDR Development Code Amendments (ongoing);
- Development Code Amendments including updates to the tree code, SEPA updates, and various administrative amendments;
- Development Code Amendments related to the MUR-70' zone;
- Informational meetings on topics such as the Middle Housing Public Participation Plan, the 2024 Comprehensive Plan Public Participation Plan, and Community Land Trusts; and
- Training for those Commissioners that attended the Washington Chapter American Planning Association annual conference in Vancouver, WA.

The Commission is looking forward to continuing work in 2023 to address:

- The 2024 Comprehensive Plan update;
- Middle Housing as part of the 2024 Comprehensive Plan update;
- The update of the Parks, Recreation, Open Space, and Arts Plan;
- Public Outreach and open houses related to the Comprehensive Plan update; and
- Transfer of Development Rights Development Code Amendments.

The Planning Commission's 2023 Agenda Planner, which provides a listing of their forthcoming meetings and the proposed topics for those meetings, is included as **Attachment B** to this memo.

#### **Discussion Questions**

In addition to the items on the Planning Commission's upcoming Agenda Planner, there may be other topics that the Council and Commission may want to discuss that may impact the workplan going forward. These topics could include:

- 1. The timing of when staff and the Commission should begin working on changes to the Development Code to implement the new Middle housing and Accessory Dwelling Unit (ADU) regulations recently passed in the State legislature.
- 2. The timing of when staff and the Commission should begin developing permanent regulations for ground-floor commercial uses in new multifamily buildings.
- 3. Any other topics the Commission and Council want to explore that may impact the Commission's work plan this year and into 2024 when the Comprehensive Plan update must be adopted.
