Well that is interesting. Since this is a policy adopted by the City Council I think we should follow the provisions of the policy. I think Eric was just trying to put a structure in place to get the naming done to highlight the new parks. I don't know of any reason why it needs to rush unless there is some provision in the grant funding. Why don't John & I add this to discussion with Mayor/Deputy Mayor for Monday night. I would suggest that you go ahead and have discussion with the Park Board and see if they are ready to make a recommendation – and if not they can continue to discuss. Then we schedule the recommendation to come forward in 2020 or delay until 2021 to meet the policy (so delay the Council process). In the staff report to the Board you could say it will come forward to Council for final adoption.

On another note – we might want to change the 6 month delay in a future discussion with the Council.

Thanks Colleen and Susana for this. In taking a quick look at the memo, I think that we should reference the Park Naming Policy in the memo and reiterate some of the criteria for the Board from the Policy, just so it is front. I think it would be also be helpful to attach the policy to this memo for the Board's reference (that may already be a part of the plan).

As for the staff recommendation, definitely supportive of Westminster Park for the park on 150th, but struggling a little bit with Traction Company Park on 185th. Very much appreciate the connection to the Interurban Line, but it seems like the connection is just distance from the interurban, which is still 2-3 blocks away. If the park was right on the interurban (similar to the Park at Town Center), it may make more sense to me. Do you think we should reach out to Vicky Stiles at the Shoreline Historical Museum to see if there is more of a connection in some way? Also ran this by Debbie quickly, and she wanted to make sure that there were no 'historical concerns' with the Traction Company (i.e., businesses practices, political/racial views, etc.) that would not look good in today's light. While it can sometimes be harsh to judge past actors with our current lens of right and wrong, this is something that occurs and we want to be mindful of. I do appreciate that none of the suggestions really resonated with me personally, so I emphasize that this is a difficult one. I also think the 'natural' elements of the park don't seem to jive with the interurban theme and name. I would suggest that staff just leave off a recommendation for this one, rather than going with the light recommendation for Traction Company Park. Happy to chat more if that is helpful.
