Joint Petitioners

The City of Shoreline (Shoreline), a non-charter optional municipal code city as provided in Title 35A RCW, and the Ronald Wastewater District (Ronald), a special purpose district operating under the authority of Title 57 RCW, (collectively the Parties) have jointly petitioned this Court for an Order of Dissolution as provided in Chapter 35.13A to be effective at 12:01 am on April 30, 2021. To facilitate a smooth assumption of the jurisdiction and responsibilities Shoreline and Ronald have requested this Court to issue an Order Directing the Transfer of Assets and Liabilities so as to grant Shoreline and Ronald the right to take the necessary steps for transferring such assets and liabilities, including but not limited to, liens, agreements, contracts, and other tangible or intangible property, and pending litigation.

1 The Court having reviewed the Joint Petition for Dissolution and any supporting
2 documentation, and otherwise fully advised on this matter, NOW, THEREFORE ORDERS
3 AND DIRECTS THE FOLLOWING:

- 4 1. The Ronald Wastewater District and the City of Shoreline shall have the authority to
5 execute any and all necessary documents to effectuate the transfer and/or assignment
6 of the following assets and liabilities, and to record, as necessary, such documents in
7 the King County Recorder's Office prior to the effective assumption date of April 30,
8 2021:
- 9 A. Any and all unsatisfied RCW Title 57 liens that the Ronald Wastewater District has
10 recorded with the King County Recorder's Office on or before February 28, 2021.
 - 11 B. Any and all unsatisfied Development Extension Agreements executed by the
12 Ronald Wastewater District, recorded or unrecorded.
 - 13 C. Any and all unsatisfied Sewer Service Agreements executed by the Ronald
14 Wastewater District, recorded or unrecorded.
 - 15 D. Any and all contracts of any type, if contractually permitted.
 - 16 E. Any and all other tangible or intangible assets and liabilities currently held by the
17 Ronald Wastewater District.
- 18 2. The Ronald Wastewater District and the City of Shoreline shall have the authority to
19 execute any and all necessary documents to substitute the City of Shoreline as the
20 Ronald Wastewater District's assignee and successor-in-interest as a party to litigation
21 pending, and where necessary obtain leave of the court, whether Ronald is a named
22 plaintiff, defendant or third party prior to the effective assumption date of April 30,
23 2021.
- 24 3. Unless the Parties agree otherwise, the assignment or transfer of rights, responsibilities,
25 and liabilities for assets and liabilities as set forth herein shall be effective at 12:01 a.m.
on April 30, 2021.

- 1 4. All assets, rights, responsibilities, or liabilities of Ronald Wastewater District
2 transferred pursuant to this Order or the Court's Order of Dissolution, shall become the
3 property of the City of Shoreline's Wastewater Utility and shall be managed as
4 provided in the applicable provisions of Title 35A RCW, including but not limited to,
5 Chapter 35A.21 RCW, Chapter 35A.34 Biennial Budgets, Chapter 35A.60 Liens, and
6 Chapter 35A.80 RCW Public Utilities; the applicable provisions of Chapter 35.67
7 RCW Sewerage Systems, Chapter 35.92 RCW Municipal Utilities, and any other
8 applicable provision of law.
- 9 5. This order is without prejudice to amendment(s), if necessary.
