

2021 Juneteenth Mural Project



Overview

ShoreLake Arts and the City of Shoreline invite artists who self-identify as BIPOC (Black, Indigenous, People of Color) to submit proposals for a community-driven mural project in Shoreline, Washington. The mural is intended to recognize the history of Juneteenth, as well as highlight its present-day relevance. The artist will design the mural and lead a group of high school students engaged with the Shoreline School District Black Student Union and Shoreline Black Lives Matter organizations in painting/installing it.

Location

The mural will be on the west-facing side of the Storage Court wall on Midvale Ave N at N 178th St. The available space for the mural is 6 feet 10 inches tall and 45 feet long. There are vertical metal bars that partition the wall into 9-foot sections, each 61 ½ square feet in size. Your proposed mural does not have to cover the entire length of the wall and may cover just a portion of it based on what is feasible within the budget. Please specify the dimensions of the mural in your proposal. The wall is already primed with white paint and clean, so little or no prep work is required.



Eligibility

- 1. Artists who are at least 18 years of age
- 2. Artists who reside within reasonable commuting distance of Shoreline, Washington
- 3. Artists who self-identify as BIPOC (Black, Indigenous, People of Color)
- 4. Artists who are eager to work with high school-aged youth in painting/installing the mural

Budget

The selected artist will receive \$3,000. This budget is all-inclusive and covers all components of the project, including artist fees, labor, materials, and transportation costs. The final budget will be agreed upon with the artist, ShoreLake Arts, and the City of Shoreline. When creating your proposal, please keep in mind that your mural may but does not have to cover the entire length of the wall, only what can be accomplished within the budget.

Design & Theme

The purpose of this project is to artistically recognize the importance of Juneteenth as both a marker of American history and a reminder of how far America has yet to go in the struggle against racism and oppression. How this is done via the medium of the mural is up to you, with the final design being agreed upon with the artist, ShoreLake Arts, and the City of Shoreline. It is highly recommended that your design not be overly complex, as high school students with little or no painting experience will be involved in the installation of the mural.

 - Artist fee for design and labor
 - Cost and descriptions of materials
