**Project Description:** The City of Shoreline is proposing to replace the existing surface water Pump Station 26 to maintain local flood protections. In addition, the project will replace the existing surface water detention pond with underground detention pipes to open additional park space. The upgraded facilities will continue to pump rainfall runoff from the surrounding neighborhood into the downstream piped system that eventually discharges into McAleer Creek. The site is zoned Mixed-Use Residential- 70-foot height limit (MUR-70). Construction is anticipated to begin Spring 2022.
