


DEDICATION



DESCRIPTION

This Re-Plat of Richmond Beach, King County, Washington, includes those portions of the blocks and streets of the Plat of Richmond Beach, King Co. Wash. heretofore recorded in the Records of King County, Washington, which were duly vacated by the board of County Commissioners of said King County, by regular orders of said Board made on the 5th day of November 1891, and on the 1st day of February 1892.

The dotted lines indicate the unvacated portions of said original plat of Richmond Beach, and the connections of this Re-Plat to said original plat are as indicated hereon. Streets, avenues, drives, alleys and railway right of way, blocks and lots are of the width, dimensions and location as indicated in figures upon the face of this Re-Plat - The lots in Block B and Block B extend westward to the line of high water only, the distances noted being in all cases more or less.
