

Not only is this an opportunity to update our emergency response and assess the need of training and tools, but it is a segway to create better partnership in building relationships between us and our schools.

to connect on a human level with our schools, youth, and parents. As many of you know, Sgt. A Bird's (well, Mavic) Eye View



Last week, Deputy Glavin and I attended an Air Support Unit pre-station at Lake Wilderness to learn about next-steps in launching Shoreline's sUAS (small Unmanned Aircraft System) program. There are *many* steps ahead - as well as FAA training - but once approved this program should be within reach.

The unit pictured here is a DJI Mavic 3T. It is the model we are likely to recommend to command based on the advice of KCSO / TAC-30 experts. Contract cities will have discretion on the make, model and capabilities of whatever they acquire provided the it is compatible with *AirData*, the program KCSO employs to track usage and fulfill public records requests.

It's our hope, by mid-summer, to have sUAS capability supporting Precinct-5 patrol...stand-by for updates.

A Bit More Than a Welfare Check

This short summary won't capture the outstanding work by deputies and detectives following Wednesday morning's welfare check at the Echo Lake Apartments.

Our partners, with some effort, placed the driver of this UHaul in-custody as he attempted drive away. Following his arrest, he was found to have two felony and additional misdemeanor warrant(s) including one for unlawful possession of a firearm. There was an interlock restriction on his DWLS/R-1 license. A pistol and suspected narcotics, including fentanyl powder, were later recovered.



CID detectives served a warrant this morning on the UHaul recovering debit/credit cards, IDs and significant stolen property tied to recent car prowls and suspected storage locker thefts. This work not only interrupted a string of property crimes, but

it took a firearm off Shoreline streets and will allow some victims to be reunited with personal effects they likely thought would be unrecovered.
