

Sgt. Akers - Work Under Water



On Friday March 24th, Sgt. William (Charlie) Akers, a 26-year KCSO veteran and member of the Marine Rescue and Dive Unit, assisted the Mercer Island Police and the Department of Natural Resources (DNR) in the recovery of a 32 ft cabin cruiser from Lake Washington. The owner of the derelict vessel had attempted to sink it but failed due to air remaining in its fuel tanks. The salvage team attached lift bags to raise the boat to the surface before pumping water out and removing the boat from the lake.

Abandoned and derelict boats threaten both public safety and the health of our marine environments. DNR, the manager and steward of 2.6 million acres of state-owned aquatic lands, will be leading the criminal investigation. Ancillary work, we know, is the lifeblood of the Sheriff's Office. We thank Sgt. Akers and so many others who share their talents *beyond* Shoreline to keep KCSO moving ahead -
