Highlights

The 7-11 standoff incident, case C24034940. Deputies on scene de-escalated a man in crisis and used a drone in conjunction with many other resources to come to a safe solution.

C24035228 – Car Jacking at Gun point. Victim was able to track vehicle and Shoreline deputies located the vehicle. Vehicle pursuit. Pursuit ended with suspects crashing into each other in separate vehicles. Two juveniles taken into custody.

C24034761 – Lojack hit. Deputies located stolen vehicle from the Lojack hit. Driver of the vehicle was taken into custody for a warrant and charges forwarded to prosecutor.

C24033399 – Vehicle Recovery. Shoreline Deputy located a stolen vehicle in a parking lot that was occupied by two. Assisting deputies responded and assisted with removing the individuals from the vehicle. One suspect booked for possession of stolen vehicle.

C24035190 —Shoreline Deputies responded to the West Coast Self Storage for a burglary in progress. Deputies responded and took custody of multiple suspects. Their vehicle was taken for a search warrant. Shoreline CIU Detectives recovered burglary evidence and unserialized firearms that included a handgun and an Ak-47 Rifle
