Highlights

On view activity was down by almost half as our calls for service stayed about the same. I will work with the Patrol Sergeants to figure out what happened.

In the A5, Walgreens and Safeway have said they happy with the uptick in officer presence and arrest/contacts made in their areas in the past month.

02-05-25 C25004054- Warrant Arrest and VUCSA investigation completed at the 14500blk of Interurban Trail. Continued area checks throughout the month have been conducted to prevent criminal activity and loitering.

02-06-25 C25004162- Robbery of the Town and Country Market. Patrol later found out that the getaway vehicle was stolen from a motel in SeaTac where vehicles can be parked overnight for people flying out of the SeaTac Airport. The suspects first used the vehicle to burglarize the victim's home in Pierce County while she was out of town. Later that night on 02-06-25 C25004207- Sgt. Merlich located the vehicle and Deputies initiated a pursuit, but due to the extreme weather and speeds the vehicle pursuit was ended. On 02-21-25 C25004054-Deputy Koontz was able to track down one of the suspects from the

robbery and the individual was placed into custody. Shoreline Detectives are now conducting a follow-up investigation on the case.

2/8/25 Recovered a stolen Corvette, the driver was a 16 year old convicted felon with a pistol in his pocket with a round in the chamber. No use of force.

2/9/25: Recovered a stolen pick up truck with a driver passed out inside. A .357 revolver was next to him, driver was a convicted felon. The truck was impounded and a large amount of narcotics was recovered after a search warrant was served.

02-12-25 C25004827- What started off as a warrant attempt at the America's Best Value Inn, turned into a suspect trying to escape and crawling through the attic crawl space. In the process the suspect broke and entered several occupied/unoccupied rooms from the ceiling in an attempt to escape. Deputies Koontz and Handley eventually entered the attic of the motel and crawled through layers of insulation and located the suspect and placed them into custody.

02-14-25 C25005055- On view warrant arrest at Storage Complex 145/ Aurora Ave N

2-18-25: Dayshift responded to what was reported a stabbing that had just occurred. The victim was treated and the scene rendered safe for Detectives.

2-19-25- C25005452- PTO Stultz and Deputy Bennett contacted Jerrold Johnson who was in the park after dark. Johnson is a known gang member who has priors for Murder 2 and Assault 3 in addition to a bevy of arrests in his long LINX history. Johnson was detained and found to have a DOC warrant. He was booked into SCORE Jail.

2-23-25 Due to our higher numbers on 4th shift, Sgt. Campbell asked two units to pair up for an emphasis unit. MPO Jackson and Deputy Goundar teamed up in one car to patrol our city hotspots. They immediately found a warrant subject and booked her into Sno county for her shoplifting warrant.
