Re: SHORELINE VIOLENT CRIMES AND TRAFFICKING DET STATS MARCH 2025

Det. Finan completed **17** outside agency assists related to gang, VICE (Human Trafficking), and social media intelligence, to include identifying criminal suspects and victims, providing gang identification and monikers, and locating social media accounts for subsequent search warrant requests. I've added his case load and activity logs below. **It should be noted that during this month, Det. Finan Identified the suspect in an Everett PD unsolved murder.**

His March activity is as follows:

- Completed 17 outside agency assists relating to social media, gang, and human trafficking intelligence.
- Attended the Regional Violent Crime Intelligence Meeting
- Helped identify Andy Vorachack as a suspect in a Seattle shooting. Vorachack was a suspect in a Shoreline assault case from Dec. 2024. I provided the Seattle Det. with social media posts showing Vorachack wearing matching clothing from their case.
- Assisted Lakewood PD Det. Merrill multiple times relating to HSI human trafficking cases.
 Provided social media intel related to trafficking suspects and victims in cases he is working and canvassed Aurora Ave for a missing juvenile trafficking victim.
- Identified a Tacoma based Pimp for Portland Det. Larsen who was investigating him for trafficking two juveniles from WA on the Portland track.

• Identified the suspect (and her associate) in an SPD shooting (SPD #25-65205) of a citizen at the Rainier Ave Safeway. Provided social media and gang intel for both.

KCSO Assists:

- Helped ID two and possibly three of the suspects in a KCSO marijuana shop robbery (C25008453)
- Assisted in monitoring intelligence related to the planned protest of Pilgrim Coffee shop in Shoreline

Notable cases:

- C25008453: Developed PC for suspect in Robbery at Town & Country market. Filed Robbery-2 charges
- <u>C24030081</u>: Received Instagram return for suspect and victim in this case. Evidence contained in the data is enough to support the charge of Human Trafficking 2nd Degree and Promoting Prostitution. Currently working on filing docs.
- C25006380, C25007884, C25007890, C25007910, C25007911, C25009091: Series of crimes, including an attempted assault at Shorecrest HS, a robbery near Shorewood HS, a shooting at Ballinger Homes, and gang tagging. All of these are related to ES Doble 13 WBP gang activity in Shoreline. I've spent the month working to identify the subjects affiliated with WBP, have made contacts with gang officers in Lynnwood, Everett, MLT, and Snohomish County, provided intel to Shoreline patrol, created an intel PowerPoint for Shoreline admin, and opened a line of communication with the admin at the two high schools. I've also written two extensive case summaries which document the subjects involved and outline the ongoing feud. This is an on-going project.
- <u>C24025798</u>: Received the Instagram data return on 14 105 Piru related accounts. Using evidence from the returns, I identified the suspect in an Everett murder (EPD #24-90045) of an innocent citizen during an attempted carjacking. I have probable cause to file felony charges on multiple subjects for armed carjackings, including for the attempted Shoreline carjacking (the original nexus), but I'm currently working with Everett to pursue the suspect in their homicide and his associates.
- C25006159: Developed probable cause for UPFA on a 11x felon and gang member based on social media postings. Subsequently identified the same individual as the suspect in a Federal Way drive-by shooting (FWPD 25-3188) and established probable cause to arrest him for the drive-by. Wrote multiple warrants for PRTT data, IG data, and CDR/ping data. Currently tracking the suspect and plan to arrest with the assistance of Tac-30.
