Kenmore's Annual Public Safety Report Showcases Crime Decline



On Monday, April 28, Chief Brandon Moen presented the annual Kenmore Police Services Report (PSR) to the Kenmore City Council during a Public Safety Workshop, which also included updates from the KC District Court, Prosecutor, Public Defense, and Regional Crisis Responders. Highlights included Kenmore's ranking among the top five safest cities in Washington by Safewise, a 50% reduction in residential burglaries, and an 18% decrease in traffic collisions.

"Thanks to the hard work and dedication of our King County deputies assigned to Kenmore, we have seen reductions in crime rates in many key areas and another year recognized as one of Washington's safest cities. I, as well as our community, thank Chief Moen and his officers for their proactive approach and responsiveness to the needs of our community."

Life-Saving Heroics: Officers Bennett and Trop Act Swiftly in Crisis

On the evening of March 12, 2025, around 1950, Deputy Austin Bennett was patrolling the Safeway parking lot when a woman urgently flagged him down. She reported a possible overdose at the Chevron station across the street. Without hesitation, Deputy Bennett responded and found a young man in his late 20s unresponsive on the ground. Following protocol, he administered Narcan at 1953. Moments later, Deputy Spencer Trop arrived and assisted in placing the man into a recovery position. Within minutes, Shoreline Fire personnel were on scene. The man soon regained consciousness and was able to speak with first responders. He declined further aid.



"Watching the body-worn camera footage of this incident was incredibly impactful. It served as a reminder of the amazing work our Shoreline deputies do every day. There is no doubt in my mind that Deputies Austin Bennett and Spencer Trop saved that man's life that night."
