I reviewed the call, and per the detail was broadcast as a Robbery, Just Occurred, but the comments stated: 5 ago... SL gone bad, Shoved RP when leaving... GOA in a TOYT... no WEPS... No INJS. The incident was put on hold with no unit information indicating who put this on hold. CA Shevchuk is researching this incident. This appears to be an outlier and not the average response time. Without this outlier the actual Priority X response time is 3.31.

4/17/2025 - 0018 – 17500 Aurora AVE N. – Broadcast for wrong-way driver – K25103536 - MPO Jackson immediately jumped on the call and the driver of the blue Honda Civic pulled into the Cadillac dealer on Aurora. Upon arrival, MPO Jackson had Fire come and check on this elderly male as Omar was worried that he may be having a medical emergency. The man appeared "confused". Fearing for the man's safety driving home, MPO Jackson had the man leave his Civic in a parking spot and he drove him home. I spoke

to Ms. Tsujikawa at the front desk, and she stated that the man contacted her to sincerely thank Omar for helping that night. Side note: MPO Jackson had just picked up his order from his favorite restaurant before this call came out and he jumped right on this without delay, thinking only of this man's safety and for the safety of the community. Pretty cool.

4/23/2025 – 0006 – Chevron at 15510 Aurora AVE N – On-view Stolen - C25012318 – Being extremely observant, Deputy Stultz first spotted a stolen plate and two females around that vehicle. One female ran off as he contacted the other one. MPO Jackson then tracked down the runner and detained them. Deputy Goundar arrived to help with the investigation interview as Deputy Stultz contacted the primary driver. Deputy Stultz ran the VIN and found the vehicle stolen. In the end, the passenger gave up the driver and provided a statement to Deputies about her friend being in possession. Deputy Stultz did the extra leg work on getting video from the Chevron showing that same female driver getting out of the vehicle in possession. Deputy Stultz checked up on this case and found that the Prosecutor did in fact charge PSV on the case. All around a great investigation and amazing teamwork by these 3 Deputies who love to work together.

Deputy Stultz is a firearms instructor, and he took it upon himself to build an entire dryfire practice setup in our garage. He has many Deputies on shift participating with him in practice scenarios using the targets and the barricade he built. Deputy Schultz says "50 clicks a day" is the goal for all of us to stay proficient and Sgt. Campbell thinks this is just a great way that he takes care of his team.

4-13-25 2014hrs C25011346- There was an ongoing issue with a person who lived at St. Margarets and numerous efforts and attempts were made to try and get the person involved but were unsuccessful. While out on Patrol Deputies Bennett and Mainaga were able to place the person into custody for a separate crime with no further incident. This drastically decreased the number of calls and complaints we would receive about this person almost daily at St. Margarets. The deputies saw an opportunity and took the initiative to get this person help and resolve the situation.

4-28-25 1702hrs C25012874-. 2B Deputies assisted Burien patrol with a felony no contact order violation where the suspect was located in the City of Shoreline. Deputies were able to have the suspect release all other innocent parties inside of the apartment. A search warrant/arrest warrant was then completed, and the suspect was taken into custody with no further incident.
