I'm following up on the suggestion posed by Mayor Roberts that the county consider purchasing units of affordable housing in developments built and operated by other entities. The chart below includes how the Veterans, Seniors and Human Services levy is utilizing "housing stability" funds which equates to funding housing units and shelter beds. It is current to October 2024 and is from discussions surrounding our budget, but I thought it would serve the need of showing that great minds think alike, and the county is already purchasing units of housing.
