### Violent Crimes And Trafficking Detective (VCAT):

- I completed 19 outside agency assists relating to social media, gang, and human trafficking intelligence.
- Attended the King County Regional Violent Crime Intelligence Meeting
- Attended regional meeting hosted by KCDPA Burns to discuss organized crime prosecution strategies for frequent gang offenders
- Identified Felony Harassment suspect for Mountlake Terrace PD case / wrote supp to establish their PC
- ID of two different ORT/ID Theft suspects for Bellevue PD / provided social media photos of one suspect wearing the same clothing as in the surveillance video
- Asst. Aberdeen PD: While listening to jail calls, discovered possible rape that occurred / wrote case supp and provided APD with intel

<u>C24030081</u>: Filed charges on S/ Jordin P. Abrego – Human Trafficking 2<sup>nd</sup>, Promoting Prostitution 1<sup>st</sup>, Assault-2, Witness Tampering. Following Abrego's arrest by SPD on my warrant, served SW on his vehicle and recovered two firearms (including one stolen out of CA) and 28 grams of cocaine. Filed additional felony charge of VUCSA-PWI. Abrego being held on \$450K bail.

<u>C25013990</u>: Rescued 17-year-old trafficking victim. Developed PC for her trafficker after writing multiple search warrants. Along with Sgt. Merclich, helped secure resources for the juvi victim to assist in her recovery from drug addiction. Case is ongoing and related to the Shoreline murder (C25016734)
