05-11-25 0958hrs C25014293-. Deputy Bennett had come in early for patrol backfill for 1st shift. He was dispatched to a mail theft call and was able to locate a witness and place the suspect into custody. Several mailboxes had been broken into, and Deputy Bennett contacted several victims and took statements from each victim. He conducted his own follow up's and worked with Shoreline CID Detectives to charge the suspect with several counts of mail theft/possession of stolen mail. This is a case that most would stop and

have Detectives continue to work the follow up investigation. Deputy Bennett took it upon himself to conduct several interviews with victims to free up detectives.

05-12-25 1455hrs C25014427- Deputies West and MPO Rodriguez were dispatched to as residence where an individual was attempting to hang himself. Deputies arrived on scene as the individual was climbing over the deck with a noose tied around his neck attached to a beam above his head. The Deputies were able to distract the individual and MPO Rodriguez was able to cut through the electrical cord. The individual then realized that he wouldn't be able to go through with his plan and voluntarily climbed back over the deck railing. The individual's significant other was grateful for the Deputies actions.
